### **Course Description**

Special topics on the study of music history, to be arranged. Topic: K-pop

### **Additional Description**

Music 2709B is a study of Korean musical culture with the musical style, historical development, and transnational context of K-pop. As such, we will visit a number of precursors and global traditions to inform studies of the music from its beginnings in Korean popular culture and commercial K-pop since the 1990s. We will engage with written texts, videos, and recordings to develop a critical lens on topics and issues such as listening, audiences, uniform music acts, political economy, mass media, race, gender, fandom, identity, geography and transnationalism. No prior training in music is required.

# **Course Prerequisites:** None

### **Learning Outcomes:**

By the end of this course, students should be able to:

- 1. Discuss the historical development of Korean popular music.
- 2. Explain how extra-musical forces such as race, class, gender, identity, geography, politics, and media shape the culture and music industry of K-pop.
- 3. Identify and describe significant recordings from K-pop and related genres of music.
- 4. Use discipline-specific terminology in the description of musical works.
- 5. Express ideas about K-pop that are researched and informed from a variety of texts.

#### Textbook

There is no textbook to purchase for this course. Weekly readings will be *required* and posted on the course website for each weekly unit.

### **Listening**

Listening examples will be provided through Spotify and YouTube. You will create a Spotify account to access the listening examples. See the course website for instructions.

# **Course-Specific Notes**

- i) **Late penalty**: The penalty for a late submission of the Reflection Report is 5% per day unless an approved extension has been arranged (see Academic Policies, section iii below). Assignments later than 5 days will receive a grade of zero.
- ii) Late discussions: Due to the nature of online discussions, extensions are not granted for missed deadlines and submissions of late discussion postings will receive a grade of zero for the Discussion Participation.
- iii) **Special note about Artificial Intelligence (AI)**: the use of AI in *any* form (e.g., as consultation, reference, to look up questions/answers, for writing, etc.) is considered academic misconduct and will be enforced. The Required Discussions, Reflection Report, and testing are to be completed in entirety by the human enrolled in this course. All resources are provided in the course for success and there is no need to use AI for this academic work.

AI cannot meet the requirements for your critical response to assigned readings, watching and learning from assigned videos, listening to music, and seeing interviews with conventions of speech, dialect and body language. As a human, writing from AI is also easy to identify. **The use of AI** *in part or in whole* **for any academic work is prohibited from this course.** 

#### **Academic Policies**

- i) Course Prerequisites: None. Unless you have either the prerequisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.
- ii) Grading scale: A+=90-100%, A=80-89%, B=70-79%, C=60-69%, D=50-59%, F=0-49%.
- iii) Academic Consideration for Student Absence & Missing Work (≥10%): Students are responsible for making up any missed classes or assignments as soon as possible. The University recognizes that a student's ability to meet their academic responsibilities may, on occasion, be impaired by medical illness. Illness may be acute (short term), or it may be chronic (long term), or chronic with acute episodes. Academic Consideration provides students with consistent, fair, and pedagogically appropriate consideration, without compromising the academic integrity of the course or program, when they have been unable to complete some component of a course due to short-term extenuating circumstances.
