## Course Objectives:

- Students will continue to become familiar with the scholarship associated with performance research.
  - $\circ$   $\;$  They will become acquainted with the scholarly discourse on the history and practice of
  - performance through weekly reading and discussing of relevant journal articles.
  - $\circ$   $\;$  They will develop strong, clear writing.
  - $\circ$   $\;$  They will gain confidence in their own contributions as professional musicians.

## **Required Texts:**

There are no required texts for this course. However, students are strongly advised to own a style guide (for example: Turabian, Kate L. *A Manual for Writers of Term Papers, Theses, and Dissertations*. 7th ed. Chicago: University of Chicago Press, 2007.) All readings will be provided in class, on OWL, and in a binder in the music library on 2-hour reserve.

# Evaluation:

- Attendance in class: 10% (unexplained / unexcused absence = 1% detracted)
- Attendance / Contribution at Article Discussion Group Preparation Meeting x 3: 5% x 3 = 15%
- Leadership of one article discussion: 15%
- TWO write-ups as respondent: 5% x 2 = 10%
- ONE write-up from the perspective of the LEADER of the discussion (approx. 500 words): 25%
- ONE write-up of article for which you were not involved in the presentation group (approx. 500 w): 25%
